### Now this is something we can all get behind...

A new national survey finds that 77 percent of Americans agree that all workers, not just those working for state and local government, should have a pension. And even though the nation is deeply divided on many other issues, support for pensions is consistent across party lines. Eighty percent of Democrats, 75 percent of Republicans and 78 percent of Independents agree that all workers should have access to a pension.

These findings are contained in a new issue brief from the National Institute on Retirement Security (NIRS), Americans' Views of State and Local Employee Retirement Plans. Download the research here.

"The COVID-19 pandemic has shined a light on the critical role that qualified, experienced state and local workers play in our lives," said Dan Doonan, NIRS executive director and report co-author. "From healthcare workers to first responders to teachers, these employees have worked tirelessly and taken immense risks this past year."

"Our research shows that Americans understand that pensions offer more than retirement security - they are a key workforce tool to help attract and retain employees. State and local governments typically offer lower salaries than the private sector, so retirement and healthcare benefits act as employee magnets," Doonan explained. "We also found interesting that nearly half of Americans say that public sector retirement benefits are about right (46 percent), while about one-third (31 percent) say the benefits are too low."

Pensions are economically efficient and also provide a sizable economic impact across the U.S. Retiree spending of public and private sector pension benefits in 2018 generated \$1.3 trillion in total economic output, supporting nearly seven million jobs across the nation. Pension spending also added nearly \$192 billion to government coffers at the federal, state and local levels. ICERS'Insight

# Retirement Benefits and Divorce

Believe us, this is one of those topics we hope we never have to discuss with any of our members. But just in case the unfortunate does happen, you can trust that ICERS will help with this difficult process.

#### How does divorce affect my retirement account?

If you were a member of Imperial County Employees' Retirement System (ICERS) while you were married or had a state registered domestic partnership, your retirement account may be considered community property by California Family Law. ICERS recommends that once a completed Dissolution Judgement and Settlement Agreement is finalized/filed with the court and signed by the court that you notify ICERS immediately. If not, you could face long delays in payment of your retirement benefits or contributions refunds payments. You may need to update your beneficiary information with ICERS as well.

#### What do I need to provide to ICERS after divorce?

ICERS will need an entire copy of the Dissolution Judgement and Settlement Agreement. Depending on the property disposition ordered by the Court, your ex-spouse/ex-state registered domestic partner may be entitled to a share of the community property portion of your retirement account. ICERS cannot tell you what portion of your retirement will be divided, if any. This should be outlined in your settlement agreement.

#### The Court has determined my ICERS account must be divided, what do I do?

If your retirement account is to be divided, A Joinder must be filed. A Joinder is a legal document that joins ICERS as a party to the dissolutions proceedings. A Domestic Relations Order (DRO) is also required with other pertaining documents. A DRO explains in detail who is entitled to a benefit, and when they are entitled to receive it. This document is signed by both parties, their attorneys (if they have obtained any), ICERS Counsel, and a Superior Court Judge. ICERS cannot accept or review a DRO until you have filed a Joinder with the Court and it has been served to ICERS. Upon doing so, the DRO should be submitted to ICERS for review prior to submitting to the Court.

#### I am retired and must divide my retirement, how is my benefit affected?

The same process applies to retirees, the only difference is that the benefit option has already been selected and cannot be changed. For example, if you selected the unmodified option at retirement and you get divorced, your ex-spouse/ex-state registered domestic partner will no longer be eligible for the 60% continuance upon your death. However, they may be entitled to a portion of your monthly benefit that is being paid to you.

If you are unable to access these documents, please contact ICERS. ICERS recommends that you contact our office for further information. 
