4. Approval of the Minutes of the September 20, 2023 adjourned regularly scheduled meeting.

**MOTION** by Armstrong, Second by Bermudez to approve the Minutes of the September 20, 2023 adjourned regularly scheduled meeting carried unanimously by those present.

5. Discussion: Confirmation that Retirement Administrator is a County Employee

**MOTION** by Prince, Second by Salinas to confirm the Board's understanding that the Retirement Administrator is a County employee carried unanimously by those present.

- 6. Presentation by Investment Consultant, Verus: Brian Kwan, Managing Director, Senior Consultant
  - A. Discussion: Enterprise Risk Tolerance Assessment

Mr. Kwan reviewed the County of Imperial's ability to incur investment risk based on the findings from recent Trustee interviews and an assessment of the financial health of the County.

B. Discussion/Action: Asset Liability Study

Mr. Kwan presented the Board with the Asset Liability Study findings and recommended the Board adopt the asset allocation specified in the recommended portfolio, which reduces Domestic Equity by 3% and increases Private Credit by 3%.

**MOTION** by Landeros, Second by Armstrong to accept Verus' recommendation to adopt the asset allocation and reduce Domestic Equity by 3% and increasing Private Credit by 3%. Motion was rejected by roll call vote: YES by Landeros, Armstrong. NO by Bermudez, Salinas, Jauregui, Prince, ABSENT Lizarraga, Plancarte.

Discussion/Action: Asset Liability Study (Continued):

**MOTION** by Prince, Second by Jauregui to accept Verus' recommendation to adopt the asset allocation and with the direction for Verus to provide the Board with a report recommending what international allocation to reduce by 3% to increase Private credit. Motion carried by a roll call vote: YES by Salinas, Jauregui, Armstrong, Prince. NO by Bermudez, Landeros. ABSENT Lizarraga, Plancarte.
